

# INTERNATIONAL STUDENTS TUITION AGREEMENT



## TERMS AND CONDITIONS OF ENROLMENT:

### Enrolments

1. All enrolments are subject to the following conditions, which become legally binding on confirmation of acceptance by the School
2. Parents/caregiver must inform the school of any sickness; behavioural problems, disability or special education needs before enrolment.
3. Parents must inform the school if any contact details change i.e. parents address/ telephone number etc.

### Academic Programme

1. Offers of Place are conditional and subject to assessment of English language competency.
2. The suitability of the ESOL programme provided will be reviewed one month after commencement and thereafter at the end of each term.
3. The school will provide tuition in accordance with that accorded to domestic students.

### Fees

1. The full fees for tuition are detailed in the official School Invoice and the School's Foreign Fee Paying Student Fees procedure.
2. Fees of \$8000 plus GST per year are payable in advance.
3. The tuition fee as invoiced includes:
  - tuition as specified in the school timetable,
  - ESOL support programme
  - orientation programme
4. Additional costs will be:
  - stationery
  - extra curricular activities e.g. sports teams, music lessons
  - field trip
  - School camps – Years 5 & 6
  - Visiting performers
  - swimming

### Refunds

1. Once a student has commenced study refunds will only be made in exceptional circumstances and according to the school Refund Policy attached.
2. Student fees are protected in the unlikely event of the school being unable to fulfill its commitment under this agreement.

### Accommodation

1. Wakari School does not supply rental, home stay, hostel facilities or private boarding accommodation.
2. The School will not accept students who are not living with at least one parent or legal guardian.

## School Rules and Attendance

1. Acceptance and compliance with school rules is a contractual obligation on the part of the student.
2. It is an obligation of the student to attend on all school days and be on time.
3. Absence or late attendance requires a telephone call or a letter signed by the Host family, Parent or Caregiver.
4. Students are obliged to comply with the laws of NZ. Failure to do so, or to comply with the school rules may lead to termination of the student's contract.
5. In such circumstances a report would be made to NZ Immigration and could result in a withdrawal of the Student Visa.

## Liability and Insurance

1. The School is not liable for any loss, damage, illness or injury to persons or property however caused, except where such liability is imposed by statute.
2. The School will have no responsibility for the student outside school hours with the exception of school events for which his/her parents/caregivers have given consent for him/her to attend.
3. Medical and dental treatment is not provided by the school. Parents have to arrange health and dental care for their children.
4. Students must have appropriate medical and travel insurance for the duration of their planned stay.

## NZ Code of Practice

The School has agreed to observe and be bound by the Code of Practice for the Pastoral Care of International Students published by the Minister of Education.
